CHAIRMAN'S REPORTS:

- **COLUMBUS STATUES AND ISSUE:**

JOHN REPORTS THAT THE ZINN PROJECT IS ABOUT THE TAKING DOWN OF AMERICA WITH HIS PROJECT. THEY COULD LOSE THEIR TAX EXEMPTION STATUS. LOU REPORTS THAT THEIR INFORMATION IS FALSE AND CAN BE LOOKED AT FOR A LAWSUIT OR SLAPSUIT FOR FACTUALLY INACCURATE INFORMATIONS. LEFT WING IS ATTACKING THE PEOPLE THAT ARE NOT USING THE ZINN ITEMS AS A TEACHER. THE ENEMY WITHIN IS THE CALANDRA INSTITUTE STILL DOING THE BUSINESS OF NOT SUPPORTING COLUMBUS. JOHN FEELS THEY SHOULD BE DEFUNDED AND CLOSED AS THEY ARE NOT FOLLOWING THEIR MISSION. JOHN REFERRED TO A VIVOLO ON THIS ISSUE. COLUMBUS CITIZENS FOUNDATION GIVES THEM \$100,000.00 A YEAR AND SHOULD BE STOPPED. JOHN WILL ASK THE HERITAGE COALITION TO ADDRESS THIS WITH CALANDRA INSTITUTE.
